Chatswood Public School Parents and Citizens' Association Notes to the Financial Statements for the Year Ended 31 December 2011

1. Reporting Entity

Chatswood Public School Parents and Citizens' Association is a body corporate under the Parents and Citizens' Incorporation Act 1976. The objects of the association are to:

- promote the interests of the school by bringing the school community into close cooperation; and
- assist in providing facilities and equipment for the school and in promoting the recreation and welfare of the students of the school.

The financial statements reflect the activities of the association, including its Canteen, Uniform Shop and Instrument Program, the operations of which are conducted through sub-committees of the association.

2. Accounting Policies

Significant accounting policies used in the preparation of these financial statements are:

- Income is recognised when received, with the exception of funds received in advance for Canteen sales, which are recognised as income when utilised
- Expenses are recognised when paid, with the exception of employment related liabilities which are recognised when incurred
- Inventory on hand is recorded at cost
- Capital expenditure, being expenditure to acquire musical instruments and other equipment which have a useful life in excess of one year, is written off in full when paid
- Income and expenditure is shown net of goods and services tax (GST) except where related GST is not recoverable. In such cases, GST is included in the expense to which it relates
