- signatures must be sought by the student from the Tutor with regard to lesson and/or hire cessation and/or the Ensemble Director(s) with regard to ensemble membership before the student returns the form to the purple Music Box prior to the end of the school term, in order to avoid additional fees being charged

Discontinuing Lessons

Parents are reminded that they signed a set of conditions which state:

- lessons can only be discontinued at the end of a term. If your child stops lessons before the end of a term,
 the full term's fees are payable to the Tutor immediately, or, if paid, are not refundable unless make-ups
 are owed
- you must notify your child's Instrument Tutor a minimum of two full school weeks prior. Failure to give sufficient notice may result in an extra term's fees being charged
- students must be currently receiving weekly lessons to be a member of an instrumental ensemble

Cancelling Instrument Hire

Parents are reminded that they signed a set of conditions which state:

- hire can only be discontinued at the end of a semester. If your child returns a hired instrument before the end of a semester, the full semester's hire fees are payable on invoice, or, if paid, are not refundable
- at the conclusion of the school year, instruments must be returned no later than the day after Presentation Night (or at the end of the previous week for students who won't be playing on Presentation Night) unless hire is being continued into the following year, in which case instruments are kept over the holiday period
- instruments must be returned to your child's Tutor at the conclusion of the final lesson on the instrument (the form must be given to the Tutor to complete and sign, and then placed in the Music Box by the student)
- please note, violin and 'cello students who change sizes of hired instruments should not return this form there is provision on our hire forms for Tutors to notify us of the return of the smaller size when you complete the new hire form for the larger instrument

Withdrawing from Ensemble Membership

Parents are reminded that they signed a set of terms which state:

- it is a condition of our Program that all students who learn their instrument through our Program, or hire an instrument from our Program, must be members of at least one of our instrument ensembles. Students who cease all instrument ensembles will be excluded from our instrument tuition program
- ensemble membership is by the semester, and a full semester's fees will be payable, no matter at what part of the semester membership is ceased

Leaving the School

Students who are changing schools must also complete this form. Tutors must be given two weeks' notice, Directors must be notified and instruments must be returned prior to leaving.

Y6 students who are leaving at the conclusion of the school year to go to high school the following year, will be issued with a separate form during Term 4.
